(1) 14K White Gold Diamond Ring

The ring is centered with a princess cut diamond in a four-prong setting. The center is surrounded by a halo, shared prong set with sixteen (16) round brilliant cut diamonds. The shoulders are each bead set with four (4) graduate, round brilliant cut diamonds. The faces are each shared prong set with six (6) graduated, round brilliant cut diamonds and one (1) bezel set, princess cut diamond. The ring measures 10.1mm at the top, rises 8.4mm above the finger, tapering to 2.0mm wide and 0.9mm thick at the base of the shank.
