The engagement ring is also accented with ten (10) channel set, princess cut natural diamonds. The wedding band is accented with nine (9) channel set, princess cut natural diamonds. The ring measures 9.3mm at the top, rises 7.2mm above the finger, tapering to 3.6mm wide and 1.2mm thick at the base of the shank.
